Our theme this year is "Focus on the Future".



The last Steering Committee meeting was held on July 1, from 6:00 to 8:30 at the NCCFD Station 84 in Nevada City. Attendees included: Susan Wiesner, Willie Brusin, Eve Collins, Bill Holman, Larry Cook, Ellen Hagan, Bill Sheatsley, Deborah Wandro, and Terry Wagner.

After eating pizza and socializing, the business meeting began with the usual reports. We have 212 members. The Treasurer's report shows that the revenues, the operating surplus, and the general fund balance are comparable to last year.

Neighborhood reps reported that there was a breakin on Applewood Ln. Terry reported on the on-going concerns of the Indian Flat neighbors regarding the use of Hirschman's Trail and its impact on water quality and wildlife. Sierra Streams is monitoring water quality and gathering data on wildlife. They will provide updates on their findings. They are looking for volunteers to help in this effort. The Indian Flat subdivision has been impacted by the trail as well. Meetings continue between county representatives and the Indian Flat/Indian Trails neighbors to resolve road safety issues as people exit at the intersection of Indian Trail and Indian Flat. Ellen reported that the emergency access road from the Haight property seems to have been graded.

The newsletter committee is preparing for the summer/fall issue which will include the picnic invitation, a map of the fire emergency access road, and an article from Sierra Streams.

The 2 year Ferrellgas contract will expire at the end of 2013. Comparing our costs with costs from the Farm Bureau and another propane company, it looks like Ferrellgas is giving us a "good shake". (The latest news is that the Steering Committee has approved a one-year extension of our Ferrellgas contract.)

The Sept 15 Family Picnic is our big up-coming event. It will be at Chris Owen's from 3:30 to dusk.The band Stepside has been booked. Our theme will be "Focus on the Future". We will invite Rem Scherzinger, the new general manager of NID to speak about his vision for the future of NID. We'll also ask Jessica Hudson, the County Librarian to speak about the new tech center at the Madelyn Helling Library. Nate Beason, our County Supervisor will be asked to speak on the General Plan update process.

The FireSafe Council has requested that a GCHNA rep speak at the July 9 Board or Supervisors meeting to give evidence about how the FireSafe Council has assisted our neighborhood in fire prevention activities in the hopes that the Board will match funds from the Fire Chiefs of Nevada County to provide a formula for permanent funding for the Council. Jeanette Clark will be asked to speak. (Jeannette Clark did speak at the meeting. We want to thank her for her very effective presentation.)

The Board of Supervisors is in the process of updating the general plan. GCHNA is looking for someone to monitor the proceedings and keep the Steering Committee updated. The next meeting is Monday, Oct 7, 2013, 6:00 at the NCCFD Station 84, Coyote Street, Nevada City.

Cement Hill Community Facilities District Guide to be Available Soon

Since August 2011 NID treated water has been flowing to many participating homeowners in the Greater Cement Hill Neighborhood. This project was more than 15 years in the making with the Nevada Irrigation District, County officials and local citizens working in partnership to accomplish something that should serve the community far into the future. In addition to having a reliable source of quality drinking water, the entire area benefits from the installation of 55 fire hydrants funded by the NID Community Investment Program.

Detailed project information will soon be available to the public online. A "Guide Booklet" will provide the background of the Community Facilities District (CFD 2007-1) and include the district boundaries, how parcels may be added, detailed construction costs and funding. Also covered will be current management and the annual reporting for tax lien purposes.

It will be found under "Financial and District Documents," which can be accessed from the "About NID" tab on the main page. Thanks go to our Division I Director Nancy Weber, NID Assistant Manager Tim Crough, and a volunteer citizens committee who have all helped to document this project.





Sierra Streams Institute Update on Hirschman's Pond Study

At the end of 2012, Sierra Streams Institute (SSI) was awarded a 3-year grant from the Sierra Nevada Conservancy (SNC), under SNC's Healthy Forests Initiative. This project is primarily focused on developing a brush and ladder-fuels reduction project at Hirschman's Pond, and will include the development of a Land Management Plan for the area, with the goal of guiding management of the property to maintain a healthy forest in perpetuity, to improve recreational opportunities, and to prevent catastrophic wildfires.

The overall goal of the proposed project is to develop a plan for a healthy forest through the reduction of forest fuel loads, thereby reducing the risk of catastrophic fire, and subsequent erosion and sedimentation. Maintaining a fire safe forest in the Hirschman's Pond area will prevent potential water quality impacts to Woods Ravine, a tributary of Deer Creek, by preventing erosion that ensues after catastrophic fires, and ensuring that the resulting sedimentation and nutrient additions to Woods Ravine are avoided. The property is currently infested with non-native plants, primarily Scotch broom and Himalayan blackberry, which greatly increase the fire danger.

Improvements to the vegetative complex in the area, and reduction of wildfire risk, would therefore have an important benefit for recreational use and overall watershed health in the Deer Creek watershed, by improving water quality, reducing erosion, and increasing native habitat.

In order to understand the current state of the Hirschman's Pond property, SSI is conducting a suite of biological surveys in the area, which will be used to inform the Land Management Plan. Our primary concern when conducting any research projects at SSI is to maintain the integrity and well being of the environment and all of the organisms living within it. Spring and early summer studies include:

- Spring bird surveys, in which we spotted dozens of bird species, including wood ducks, belted kingfishers, Canada geese, and acorn woodpeckers
- 2 weeks of mammal surveys, in which we identified multiple deer mice, dusky-footed wood rats, and a striped skunk!
- Amphibian and reptile surveys (beginning the week of 7/22)
- Forest structure and vegetation surveys
- Water quality analysis

We've had quite a few members of the neighborhood sign up to volunteer to help us with these projects, and are exceptionally grateful for those of you who have already contributed time & meaningful data. Notice of General Plan Land Use Element Amendment

The Nevada County Community Development Agency Planning Department sent a notice on June 21, 2013 regarding the update process for Phase I which will be a policy level "refresh" of the Land Use Element, rather than a comprehensive effort that would make any fundamental changes. Currently, the Planning Department is compiling a contact list of individuals, organizations, agencies and other entities that are interested in being part of the General Plan Land Use Element Update process. Public involvement is essential to the planning process. Fall Fire Prevention Activities

With the smell of smoke in the air from the nearby American River fire in Placer County, we are reminded that living in the Sierra Nevada foothills poses a very high wildfire threat to our community. Attaining defensible space – and keeping it – requires year round activities. Here's a calendar of reminders for fall to ensure you're always ready, no matter where and when a fire occurs:

SEPTEMBER

September often brings North winds and Red Flag Warnings to our area. This month is often the height of wildfire season due to these weather conditions. Work to keep fine fuels (leaves, grasses and pine needles) at least 10 feet from structures to protect your home from flying embers which may ignite your home during a wildfire.

OCTOBER

Fire prevention week is the first week in October. When daylight savings time arrives, remember to check your smoke detector batteries. Do you have a reflective address sign at your home? If not, get one! Moments matter during medical emergencies and first responders need to be able to find you quickly.

NOVEMBER

Fall is a great time to manage vegetation and create defensible space. It's cooler, you have more opportunities to burn (if you elect to do so), and it is much safer. After the first good soaking rain, burning will be allowed. Always be sure to contact the Northern Sierra Air Quality Management District (530-272-2465) to ensure it is a permissive burn day prior to lighting a pile. Please burn hot, clean fires to avoid creating smoke nuisances.


Clearly, fire prevention is an activity that must be ongoing in order to be effective. It is not a matter of if, but when and where, another wildfire will occur. September 11, 2013 marks the 25th anniversary of the 49'er Fire. The 49'er Fire burned over 33,700 acres and 312 structures and still ranks as the 17th largest wildfire in California history by structures lost. Once a fire is ignited, it is too late to take action. Please do your part to be prepared year round – it affects everyone in the community.

Poison Oak

Poison oak is widespread throughout the mountains and valleys of California. It thrives in shady canyons and riparian habitats. Poison oak is a woody shrub or vine that loses its leaves in winter. In open areas under full sunlight, it forms a dense, leafy shrub usually 1 to 6 feet high. In shaded areas, such as oak woodlands, it grows as a climbing vine, supporting itself on other vegetation or upright objects using its aerial roots. Leaves normally consist of three leaflets with the stalk of the central leaflet being longer than those of the other two. Each leaflet is 1 to 4 inches long and smooth with toothed or somewhat lobed edges.

Contact with poison oak leaves or



it. Within 1 to 6 days, skin irritation and itching will be followed by water blisters, which can exude serum. Contrary to popular belief, the serum does not transmit the rash to other parts of the body or to other people.


The best precaution is to know what poison oak looks like at all seasons and don't touch it. Be aware that you can get poison oak by petting a dog that's rubbed against the plant. Know also that burning poison oak disperses the oils via the smoke particles. Breathing this smoke can cause severe respiratory irritation.

After coming in contact with the allergen, the best way to prevent skin irritation is to pour rubbing alcohol over the exposed area then wash with plenty of cold water. If isopropyl alcohol is not available, use cold water by itself to help dilute the oil and keep the rash from spreading. The product Technu, which most drug stores sell, will remove the poison oak oil from your skin. You should wash the contacted areas within 2 to 8 hours after exposure.

Enjoy our Nevada County trails taking precautions against poison oak.


