GCHNA'S Vision For Open Space Collaboration..

The Greater Cement Hill Neighborhood Association (GCHNA) extends from Sugarloaf Mountain on its eastern edge, to Highway 49, and then to the ridgeline that overlooks the South Yuba River canyon. This area includes lands which are ancestral homeland of the Nevada City Rancheria Nisenan Tribe and several sites of gold rush diggings. The organization was formed in 1990 during the Nevada County General Plan update to be a voice for appropriate land use planning. We serve over 475 property owners or tenants and actively work to maintain our status as a FireWise Community. We publish seasonal newsletters, reaching out to neighbors and we sponsor educational and social events. We communicate with residents and provide a common forum through regular meetings of our Steering Committee comprised of 15 neighborhood areas or road representatives. The neighborhood is entirely within Nevada County yet hosts over 200 acres of Nevada City's Open Space within its boundaries.

This article will serve as an informational piece for all residents and civic leaders by sharing some history of these Open Spaces and by expressing our neighborhood's concern regarding vegetation control, habitat and cultural preservation, homeless issues, and fire abatement on these properties.

Nevada City's General Plan Vision Statement speaks of a "distinct city surrounded by a green wooded enclosure" and civic leaders chose to preserve important historic lands within the Cement Hill Neighborhood to fulfill this vision. We applaud this forethought. The development and stewardship of these Open Space parcels are of particular interest to us as they are destined to be increasingly enjoyed by the public.

The Old Airport: The City acquired this 109-acre airfield property in 1935. Completely surrounded by the County and within GCHNA's neighborhood, the Old Airport is two miles from town center. It is zoned Agricultural Forestry in the City's General Plan. No serious development steps have been taken for decades. The City is currently entertaining proposals for a 30-acre solar farm but none have been received. They are also proposing a City Storage Yard on the site. During the planning process it does not appear that an overall management plan for the entire area including fire risk, homeless issues and emergency evacuation has been properly addressed to date.

Hirschman's Pond: Between 2004 and 2009, the City purchased Hirschman's Pond with grant funds and was gifted a 4-mile strip of land adjacent to Highway 49 as part of the Indian Trails subdivision. Nevada City also purchased a small parcel from the NC Elks to provide parking and a caretaker's cottage. Through a partnership with the Bear Yuba Land Trust, a 2.4-mile Hirschman's Trail was created for passive recreation and a barrier free route to the pond. This is now a very popular destination. These lands form our neighborhood's southern border and we are grateful for all the work done to reduce flammable undergrowth and provide residents and visitors easy access to nature. The neighborhood



wants to be kept appraised of ongoing, sustainable management efforts.

Sugarloaf Mountain: In 2011 the City purchased the 36-acre promontory called Sugarloaf Mountain, also with grant funding.

It is the iconic backdrop to the town and the eastern boundary of our neighborhood. The homeless population that had been living there were recently relocated as they had created an imminent safety and wildfire risk. This was accomplished through a model collaboration of the City and County using specially designated Federal Funds. We look forward to continued communication with City, County and The Bear Yuba Land Trust as an acknowledged stake holder in this project.

In summary, GCHNA's neighborhood incorporates City, County and State lands as well as approximately 23 acres of BLM land. These 23 acres have been untouched for decades and in great need of fire abatement. We have chosen to live in this wild land-urban interface and we are working to reduce the heightened fire risk within our neighborhood. As private landowners, we are responsible for our properties and we want to see the same responsibility demonstrated for their publicly held lands which we also value and that impact our safety. GCHNA looks forward to working collaboratively with all relevant agencies and asks that our neighborhood be included as you adopt a comprehensive management plan for designated publicly owned Open Spaces. Through our relationships, we will foster responsible stewardship for future generations.

The Fire Safety Advisory Council

New In Nevada City and bringing safety to the Greater Cement Hill Neighborhood By Annette Seabury

The Fire Safe Advisory Council was founded in March of 2020"To promote public fire safety and community involvement to protect Nevada City residents, business owners, visitors and structures from wildfire, establish objectives to support overall vegetation management and wildfire mitigation, identify funding sources, and promote public education and awareness."

The Board is comprised of the Mayor of Nevada City, Erin Ruark-Minett, the Fire Chief of Nevada City Sam Goodspeed, the Director of the Sierra Fund Carrie Monohan, and assorted members of the community including myself, Sam Mitchell, Teri Voorhes, Richard Thomas, Terry Anderson and Pete Williams who has been helping us keep our vision and intent clear and focused. This is a powerful group of individuals with the ability to make changes this area has never seen before, and desperately needs.

I applied for the committee seat and our meetings began within a week of my acceptance back in April. I am also a member of the GCHNA Steering Committee and as many of you know, my property backs up to the Old Airport. Living in this neighborhood I am keenly aware of the need for fire abatement. I am also a Defensible Space Advisor with the FireSafe Council of Nevada County. In addition all that, I have recently signed up for a certification course as a Wildfire Mitigation Specialist.

There is a background to my interest in this committee and my

other interests. Aside from the obvious need of fire mitigation in my surrounding environment,I am also a firehouse brat from 30+ years back. My father worked with the San Ramon Valley Fire District as a Director for many years. As a result, I spent the better part of my youth in assorted firehouses touring with Dad. He would spend hours chatting with the men and women who worked in the area, making sure equipment, facilities and needs were all being met or exceeded. He wanted nothing but the best for our first responders, and he made sure it happened. We owned 2 antique engines and would ride them to the store on occasion so dad could "stretch their legs" and I was often found doing homework in the kitchen of station 52 while Dad held meetings with the crew there. You could say that fire safety is in my blood.

My personal goal of working on this committee is to see a cohesive relationship of county, city and independent homeowners all working towards the same thing: wildfire mitigation. Now more than ever we need to come together and solve the problem of property neglect on all fronts. I hope to see this come to fruition sooner than later. I look forward to the Old Airport becoming a place of safety, wild animal habitat refuge and human enjoyment. This can, and will, happen through community support,

volunteer programs, city officials, county representatives and homeowners all coming together with the same intention building a safer Nevada City, and ultimately Nevada County. I feel the Fire Safe Advisory Council of Nevada City will be the springboard of action the area needs and I am very excited to be a part of it!

Annual Fire Mitigation Report

Part of being a recognized Firewise USA Community requires reporting the ongoing work residents complete each year to reduce wildfire risks, while addressing the areas identified in their community wildfire assessment plan. Every year participating communities must submit an annual renewal to maintain their "in good standing" status.



That risk reduction investment of all hours worked and monies spent on properties is our community effort to reduce wildfire risk in the calendar year. Our minimum this year was \$25.43 per each of the 405 homes in our Greater Cement Hill community, totaling \$10,299.15. I am pleased to announce that the forty-seven homes that submitted their mitigation forms toward our 2020 goal totaled \$411,239.41. Our contribution along with the other Firewise communities help in getting "in kind" grants for Nevada County.

Thank you to neighbors who keep their property as firesafe as possible. The enclosed up-dated Mitigation form for 2021 reflects the essential concerns of a Defensible Space Advisory Visit. We hope you'll use it as a guide as you do defensible space work on your property this year.

Firesafe Mitigation Form Household Fire Risk Contributions For Gchna – 2021

Home Ignition Zone

House - 0 To 5 Feet From Foundation (hours invested on projects) Risk reduction roof to foundation. Examples:

- Clean litter from roof and gutters
- Screen vents, enclose soffits and eaves
- Clean and clear under decks (flammables and vegetation)
- Fire resistant roofing, siding or decking
- Replace mulch with gravel and stone
- Remove pine needles and leaves
- Trim back trees that hang over 5 foot areas near foundation.
- Move firewood 30 feet from house and cover with a Firesafe tarp

Hours_____ # of people_____ Materials \$_____

Intermediate Zone

5 – 30 Feet From House

- Clear vegetation from under large stationary propane tanks
- Create fuel breaks with driveways, walkways/paths, patios, dry creeks
- Space trees with an 18' separation between tree canopies
- Reduce all ladder fuels, prune shorter trees up to 1/3 of overall tree height
- Thin and limb up all trees reducing distance to minimum of 18' between the crowns
- Cluster trees and shrubs to break up the continuity of vegetation to discourage fire flow
- Tree canopy no closer that ten feet to the edge of structure

Extended Zone

Extended Zone 30 – 100 Feet From House

- Remove all needles within 30 feet of house
- Thin trees and ladder fuels, small conifers growing between mature trees
- Remove vegetation adjacent to storage sheds
- Trees 30 60 feet from home should have 12 feet between canopy tops

- Chipper rental, fuel, disposal fees
- Green waste removal fees, number of runs

Jeff Cowitz's Property


Jeff Cowitz' property on Gochine is more firesafe. The ground was cleared and manzanita removed or trimmed so falling embers wouldn't travel toward the house, trees were limbed to eliminate ladder fuel, small pines were cut and dead material cut from larger trees, and firebreaks were established along the road. Firefighters will see that they'll be able to get in and out of the property safely. Jeff added, "The recent fire here started as a grass fire. So, clearing out low brush, as well as trimming manzanita up away from the ground is important to subdue the spread of flames."

Crown Tree Service did an excellent job with an 8-man crew for 5 days. Of course, it's expensive, and we all can't afford that, but we can all do a bit. Winter and spring are the best times to work. Scotch Broom roots can be dug out with a shovel or you can borrow a weed wrench from the FireSafe Council. Burning brush is now allowed. Permits are available from mynevadacounty.com and 530-274-7928 is the number to call for permissive burn day information.

Fire season will come again. Each property made more defensible makes each of us safer.

Good News For The Nisenan!

The Nevada County Board of Supervisors has approved a resolution recognizing the Nisenan tribe's historical, cultural and continued significance to Nevada County and the state.



Supervisors on Tuesday unanimously approved the resolution, which supports federal recognition of the tribe. Shelly Covert, the executive director for the California Heritage: Indigenous Research Project and the spokesperson for the Nevada City Nisenan Rancheria said this resolution provides the backing she needs to approach U.S. Rep. Doug La-Malfa about the issue of federal recognition.

The resolution is one of the first steps to restoring recognition long overdue. "If we don't have local community support, how are we supposed to convince Congress, the House or the Senate or the president?"

The history of the tribe's recognition and termination is "complicated and includes unratified treaties, presidential action, congressional legislation, judicial judgments," a release states.

Many of the original treaties established between the native population and the encroaching settlers in the 1850s were not ratified, which left the indigenous population in California in worse shape



than tribes further east.

The Nisenan people lived all over the area Nevada City now knows as Cement Hill and maintained an amicable relationship with the Craig family, Cement Hill homesteaders Covert identified as "Indian friendly. Old man Craig went out and said 'You can stay here,' but asked Nisenan Chief Charlie Cully if he would move the Nisenan to the other hill because he wanted to start a winery."

Covert said that land became the Nevada City Rancheria after President Woodrow Wilson issued an executive order in 1913.

Seventy-five acres of Cement Hill became federal trust land governed by the tribal government, then a federally recognized entity.

That recognition was rescinded in 1953, when the Nevada City Rancheria became one of the 44 rancherias "illegally" terminated by the Rancheria Termination Act. Forty-one of those rancherias have since had their recognition restored.The Nisenan Rancheria is not one of those.



Covert said the tribe is eager to acquire recognition, but if ever granted land again, would not use it to build casinos. She has yet to see what real self-determination and governance looks like, but she hopes recognition may provide her people with a foundation to think about comprehensive economic development programs that promote clean energy.


