<b>Home Ignition Zone - HOUSE - 0 to 5 Feet from foundation</b> (roof to foundation risk reduction) <ul style="list-style-type: none"> <li><input type="checkbox"/> Clean litter from roof and gutters</li> <li><input type="checkbox"/> Screen vents, enclose soffits and eaves</li> <li><input type="checkbox"/> Clean and clear under decks (flammables and vegetation)</li> <li><input type="checkbox"/> Fire resistant roofing, siding or decking</li> <li><input type="checkbox"/> Replace mulch with gravel and stone</li> <li><input type="checkbox"/> Remove pine needles and leaves</li> <li><input type="checkbox"/> Trim back trees that hang over 5 foot areas near foundation</li> <li><input type="checkbox"/> Move firewood 30 feet from house and cover with a Firesafe tarp</li> </ul>	Hours _____ # People _____ Cost of Materials \$ _____
<b>Intermediate Zone - 5 to 30 Feet from House</b> <ul style="list-style-type: none"> <li><input type="checkbox"/> Clear vegetation from under large stationary propane tanks</li> <li><input type="checkbox"/> Create fuel breaks with driveways, walkways/paths, patios, dry creeks</li> <li><input type="checkbox"/> Space trees with an 18' separation between tree canopies</li> <li><input type="checkbox"/> Reduce all ladder fuels, prune shorter trees up to 1/3 of overall tree height</li> <li><input type="checkbox"/> Thin and limb up all trees reducing distance to minimum of 18' between the crowns</li> <li><input type="checkbox"/> Cluster trees and shrubs to break up the continuity of vegetation to discourage fire flow</li> <li><input type="checkbox"/> Tree canopy no closer than ten feet to the edge of structure</li> </ul>	Hours _____ # People _____ Cost of Materials \$ _____
