What stands today is the result of thousands of hours of volunteer expertise, research, and dedication to excellence. GCHNA has become the template by which other neighborhood associations model themselves. Our by-laws are impressive. The Mission Statement and its Purposes generate a vision



Board of Supervisors' Response to BLM



Excerpt that pertains to the Cement Hill neighborhood:

"3. Cement Hill Parcel: The County of Nevada requests BLM retains in federal ownership and manages as public Open Space.

The rationale for this request is: (a) This property is zoned public Open Space by Nevada County and Nevada City in their General Plans, and has been in federal ownership for over 100 years. (b) This property is within walking dis-

tance from Nevada City, and may have educational significance for biological and historical studies.

(c) This property is one of the few sizable Open Space properties in existence near Nevada City available to the public for use and enjoyment.

(d) This property has local historical importance related to the Gold Rush era and the Nisenan tribe.

(e) There is a strong local community interest in its preservation.

The Country School

As the Eden Ranch housing development on Highway 49 progresses, it is interesting to note that the Indian Flat area was once host to the Indian Flat Grade School. It was situated across from The Willo restaurant on the opposite side of Newtown Road. The single room schoolhouse once stood at the lower end of the building standing there today. During World War H, use of the school was discontinued and the schoolhouse and property were sold. The children of the area were bused to Nevada City along with children from other rural communities.



With one exception, the schoolhouse was patterned after most of the schools of that early time. It lacked the belfry that adorned the rural schoolhouses of that era. (A case in point is the Kentucky Flat or Newtown Schoolhouse as it is now called. The schoolhouse there is still intact and used as a Community Center.) Students were summoned to class by the ringing of a six-inch

miniature liberty bell with a wooden handle. Waving the bell vigorously with a good strong arm was sufficient to bring the children on the run even though they may have been in the far corners of the schoolyard. The schoolyard extended to the boundary of present day Highway State Route 49. The only other building on the property consisted of a woodshed/ pump-house installed over a hand dug and rock lined well. It also contained the season's supply of wood for heating purposes.

A large wood-burning furnace in the back end of the room heated the schoolroom and on a cold morning everyone huddled close around it before class was in session. A student-janitor was selected by a roster and had to be in service for one week. It was his/her duty to sweep the floor twice during the week, tidy up the room daily, empty the waste paper basket and bring in a supply of wood for the following day. A fresh bucket of water was drawn from the well each morning and put on the shelf next to the door. If one didn't want to use the long handled dipper that was available, they could bring their own cup from home, Most were satisfied with partaking of their drink from the dipper.

The premises were adorned by two outhouses located on the lower end of the schoolyard, one for each gender. A raised band with two fingers extended would gain permission to do a fast trot down to the privy. It was also the everyday duty of the student-janitor-for-the-week to see that the catalogs had enough remaining pages for the day.

The Indian Flat Community Hall was the only other building next to the schoolyard. The Hall was sold and then removed by Tom Coan who used the lumber in the construction of the Dance Hall and Service Station that became known as "Uncle Tom's Cabin."



On a personal note, I transferred into the Indian Flat School from Liberty Grammar School in Tulare, California in October of 1921. To my surprise, I found I was the only one in the 4th grade -I was a class-of-one! This was the case until I graduated in 1926. One diploma was to be issued in our school that year and it was mine. After all of the rest of the pupils had gone home, the teacher, Miss Lucille Marsh, told me that my diploma was supposed to have been delivered by a member from the County Superintendent of Schools Office. After waiting around a half-hour or so, she closed the schoolhouse and told me that it would be mailed to me at home. As we were walking out of the gate, the courier arrived. The three of us had a five-minute ceremony-of-sorts and after shaking hands, I tucked the diploma into my lunch bucket and walked home for the last time a distance of two miles.

(f) Preservation as Open Space is consistent with County General Plan policies which encourage preservation of open spaces within existing residential subdivisions (Policy 6.8) and acknowledge the importance of Open Space preservation for the purposes of natural resource protection and outdoor recreation use (Policy 6.1).

Further, the County requests that there be a dialog with the City of Nevada City regarding the possibility of an easement for an access to their old airport property."

Affordable Housing - Second Units

GCHNA recently formed a subcommittee to give input to the Board of Supervisors on their proposal to allow low income second units to be built throughout Nevada County

This subcommittee supports efforts to increase affordability of housing to low and middle income families in Nevada County but have serious concerns about allowing the doubling of densities in our rural areas and in areas where there are already fire, traffic and environmental problems. Second units are already allowed in Grass Valley and Nevada City, which are appropriate areas as they provide needed services and infrastructure.

In our recent survey, the majority of you -73% - were opposed to the building of affordable second units in our neighborhood other than the granny units that are already allowed. This, however, may not be an option so we have met with other neighborhood representatives to craft a compromise proposal that asks the Board to consider a trial period of 3 years and allowing 30 units to be built within the community regions which conforms to the main tenet of the General Plan which directs development into the community region.

We asked that these units not be allowed in areas designated by CDF. as very high fire hazard zones unless CDF. is willing to give an exemption on a case by case basis. We insist that these homes truly be low income houses with some sort of monitoring program and they be limited in size to 800 sq. ft. to help insure affordability.

The Affordable Housing Task Force admits that allowing 2nd units will have little impact on solving the affordable housing issue but they have been pushing the idea forward anyway. We will continue our involvement with this issue and press to have our GCHNA concerns heard.

New Ferrellgas Contract


The GCHNA Propane Committee and Ferrellgas have reached an agreement for the Association's propane needs. This new contract was signed in September,2000 and will be for a three year term.

- 1. Prices to be .35 per gallon over wholesale 'rack' price.
- 2. Free 50 gallons for new customers.
- 3. Free 50 gallons for each member household each year for the next 3 years.

How can you take advantage of the membership bonus? When you receive your next bill and are sure that your membership is up-todate, call Ferrellgas and state that you are a member of The Greater Cement Hill Neighborhood Association and give the Customer Service Representative your Customer Number. After checking your account, she will tell you to <u>credit your bill for \$55.45</u> or she will subtract that amount from your bill if you are on a monthly payment plan.
