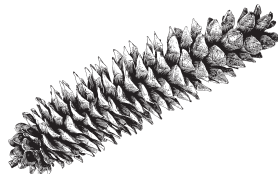
Annual Meeting On Zoom

This is a wonderful place to call home and it serves us well to remember those who have called this their land for many generations before the rest of us arrived: Our oldest kin, the Nisenan people whose Rancheria was right here until it was torn down a few decades ago. We hope they will find a worthy place to celebrate their history and culture in one of the those open spaces here which await new stewardship.

Our neighbors on the GCHNA Steering Committee made this presidential exercise an easy one. Special thanks to my fellow officers Ellen Hagan and Susan Wiesner. We have continued some great traditions like our Firewise Community status and we keep benefiting from the monumental project of earlier contributors to bring treated and pressurized water to our neighborhood. We updated our by-laws to where we have a better chance to live up to their spirit and work within their framework. The Transportation Commission has plans to calm traffic on Highway 49 and hopefully make our way into Nevada City safer over time. We've also had successes raising awareness and making some improvements of emergency evacuation routes. The location of our fire hydrants is now available online at the NID web site. Nevada County secured the funds for thorough vegetation clearing and fire safety work along Cement Hill Road. We are told that this should happen within the next year or two.

We're slowly moving towards the Internet age with email blasts, electronic newsletters like this, a collaborative member inventory and maybe - hopefully - faster Internet connections to our homes. Thanks to William Mandel for attending to GCHNA's website and email blasts.

One of our biggest challenges and opportunities lies in good stewardship of the open spaces Nevada City owns in our neighborhood: Sugarloaf Mountain, Old Airport and Hirschman's Pond. We need a sustained, multi-agency platform to ensure fire safety, preserve wildlife habitat, and reduce and eventually eliminate invasive species. Nevada County and Supervisor Heidi Hall's staff have been receptive to supporting us in this effort, but one of the challenges will be to find a friend on the City Council of Nevada City who is willing to work with us long-term. Plans to develop a solar field on the eastern part of the Old Airport are still in the making and our requests and preferences have found their way into the requirements document. Thanks to Justin Sternberg's continued efforts and several local agencies, the homeless situation on Sugarloaf mountain and the wildfire dangers that come with that have greatly improved. Somehow I ended up with a gavel that needs a new owner and I encourage every member of GCHNA to consider stepping forward or identify candidates for taking the lead for the next few years. Being presidential is both a high aim and good exercise. I assure you, fun can be had on this job.

Reflecting on the Jones Fire

My husband and I have been back in our house for over a week now after being evacuated during the Jones fire. We live on Cedarson Road just above Hwy 49 about 1 mile as the crow flies from Independence Trail which burned. I still wake up each morning feeling grateful that I've slept in my own bed.

Thank you to all the firefighters on the ground and in the air who put their lives at risk for us. We're grateful to the bulldozer operators who cleared space around our house and along the emergency access road. A special thanks to Jack Harvey with CalFire for arranging multiple loads of water to assist us in bringing our road to a condition better than before.

When we drive our road and look out our windows now we see evidence of the considerable bulldozer work that was done from above our property to Bodie Ridge Road and from Cedarson Road to the highway. From our dining room window we now see churned dirt and tree trunks on the ground. The firefighters worked hard to keep our home safe.

So, what have we learned? Our evacuation experience reinforced the need for preparation. Our lists worked and enabled us to "keep our heads". I've already added things to my "grab at the last minute" list. Next time I'd grab my good pair of barber scissors. YubaNet and the Ready Nevada County dashboard kept us as up to date as was possible. How can we do better? We have trees to cut down next winter.

What I know is that each of us has to take responsibility for making our home defensible and to be ready to keep ourselves safe. Use the many

resources like the Ready, Set, Go guide and the FireSafe Council website to learn what you need to know. Does your road provide easy access for fire equipment? Decide now what work you'll do this winter/spring to improve your house and property. If you haven't yet had an assessment from the FireSafe Council, call. Beth Enoch and Annette Seabury will be happy to help you. We're out of the woods for the moment, but the threat of wildfire will be with us for a long time. Make a plan for the future.

GCHNA needs your data on work you've done this year to make your property more firesafe.

Please send us your data using the form provided. It's easy! If you drive around our Greater Cement Hill area, you'll see significant efforts to create defensible space. The recent threat from the Jones fire reinforces how important it is that we give our firefighters a "fighting chance" to save our property. Thank you to those who commit time and money to making our neighborhood safer.

In order to maintain our National Accreditation as a Firewise Community, GCHNA must complete an annual report which includes a form called Mitigation and Risk Contribution. It is the way we demonstrate a measurable level of effort per property for reducing wildfire risk. The time is nearing to submit the report. Beth needs your name and address, a description of the work done, and the hours spent or money paid to others for work on fire safety efforts. The form is included here and also on the gchna.com website. Any questions, please call Beth

Enoch at 530-687-5570. At the top of the form, Beth tells you how to get the information to her. Please help!

Do You Have An Evacuation Tag?

The Nevada County Sheriff's Office is providing free "EVACUATED" tags for residents to place in a highly visible place such as a door, reflective address sign, mailbox, fence, or gate as they evacuate their residence during an emergency. These tags will help first responders swiftly identify which homes have been evacuated so they can focus their attention on those who still need help and decrease overall evacuation times.

"In 2019 our community stepped up their preparedness and we are excited to add this new tool to the overall recommended emergency plan. It is a compliment, not a replacement of the best practices we advocate, like having a go bag ready, being familiar with the Hi-Lo evacuation siren, and knowing evacuation routes," says Program Manager, Paul Cummings.
