Dwelling Unit / Home	<ul style="list-style-type: none">• Remove pine needles and leaf litter from roof and gutters• Replace vinyl gutters with metal gutters• Improvements to exterior to increase resistance to ignition• Install fire resistant screen vents• Enclose soffits and eaves• Clean and clear under decks and porches (flammables and vegetation)• Add fire resistant roofing, siding or decking• Inspect roof, replaced missing shingles• Trim back trees close to the house or structure that hang over roof tops

Landscaping (0 to 100 feet from base of dwelling unit)	<ul style="list-style-type: none">• Installation of hardscaping• Replace combustible mulch with gravel and stone• Removal of trees and shrubs• Raking and removal of pine needles, leaves, ground litter and debris• Trimming/limbing of trees• Moving firewood at least 30 feet from house and cover with a fire safe tarp• Lawn and native grass maintenance	

3. Common Areas / Roads (HOA or other jointly owned property)	<ul style="list-style-type: none"> • Tree thinning • Masturbation and brush removal • Grass maintenance • Fire break construction • Work/road parties
